In a Spiritual Direction relationship, sexual intimacy between a director and a client is never appropriate. If sexual intimacy or verbal or physical abuse occurs, it should be reported.

Generally speaking, information provided by and to a client during sessions with a Spiritual Director is confidential, and the Director cannot disclose the information without the client's consent. Unless subpoenaed by the courts, I will not disclose your information. The exception to this rule is if I determine you are a threat to yourself or anyone else. Under these conditions, I am bound by statute to take action to protect the parties involved. You have a right to access any records and written information I may have.

I have worked as a Psychologist at the South Dakota Developmental Center and at the Minnesota Correctional Facility-Faribault. I worked as a Therapist at the Northeastern Mental Health Center in Redfield, SD.

I am a Licensed Professional Clinical Counselor in the State Of Minnesota and a Licensed Professional Counselor in the State of South Dakota.
